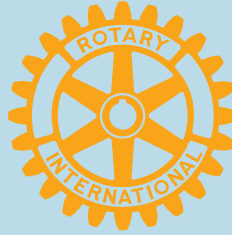

MINUTES OF THE 5th BOARD MEETING

Date: 17th November 2019

Time 7.30 Pm

The meeting was called to order by Club President at 7.30 pm. He thanks to all participants to be present in time. Minutes of the last board meeting has been approved unanimously and afterwards meeting proceed as per the agenda as following:

1. President has given an update to the board on club activities. Three members already joined with us. Club assembly by DG and Leadership training by DG elect also been completed. We also completed a Family night.
2. President now asked the Membership committee chair to present the members classification study report. The committee chair present the report and after discussion it has been approved by the board to do next course of actions.
