MINUTES OF THE 7th BOARD MEETING


Venue: Residence of IPP

The meeting was called to order by Club President at 7.30 pm. He thanks to all participants to be present in time. Minutes of the last board meeting has been approved unanimously and afterwards meeting proceed as per the agenda as following:

- 1. President has given a speech on year plan and strategic plan which was prepared at the beginning of the year. He discussed every point of the goals which needs to achieve and progress has been done by the last six months.
- 2. Membership committee chair told that already three members joined with us and one gust will join in our next regular meeting. He proposed to give an opportunity to join member's wife with a cost of RI dues and District dues. A discussion has been done on the proposal and board approved the proposal unanimously.
- 3. Project committee chair propose to join a joint project with Dhaka Prime of distribution of blanket. The cost of the project is Tk. 10,000 and the full cost will be borne by the president. Board approved the project.
- 4. - 5. Foundation committee chair informed the board that our contribution to annual foundation will be around \$5400. Board congratulate Mr. Chair Kazi Saiful Hoque.
