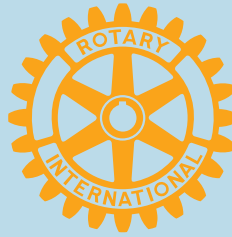

MINUTES OF THE 10th BOARD MEETING

The meeting was called to order by Club President at 3 pm. He thanks to all participants to be present in time. Minutes of the last board meeting has been approved unanimously and afterwards meeting proceed as per the agenda as following:

1. President has told that we are very much close to the end of our Rotary year. He told that as per our year plan progress report are as follows:

3. Project committee chair update the board that we joined with RC Dhaka with a long time and big budget CORONA Food support program. Board approved the proposal as post facto approval.
